Documents:

- A completed Bequest Intention Letter (see following page).
- The portion of your will or trust or other testamentary instrument that references the American Camp Association: Camp Twin Creeks Campership Fund and includes the document's signature page and date of execution.
- A copy of the beneficiary designation form for a bequest made via your retirement plan and/or life insurance policy that lists the American Camp Association: Camp Twin Creeks Campership Fund as a primary beneficiary.
- Any other relevant documentation (or pages) that include provisions for the American Camp Association: Camp Twin Creeks Campership Fund.

Sample language to use in the actual bequest:

"I give [ \$\_\_\_\_\_ OR an amount equal to X percent of the residue of my estate/thereof ] to the American Camp Association, a nonprofit corporation, for the purposes of the Camp Twin Creeks Campership Fund."

- Securities and mutual funds that may reduce your capital gains taxes ([click here for giving information](#))
- Life income gifts, such as charitable gift annuities and charitable remainder trusts, that pay you an income during your lifetime while generating a current income tax deduction
- Gifts from retirement plan assets that can reduce your income tax and taxes your heirs might have to pay
- Charitable lead trusts that pay an annual amount to Twin Creek's Campership Fund and then distribute to heirs at a reduced transfer tax cost
